Parent and Student/Athlete Agreement to Participate Form

St. Mary's conducts a program of interscholastic athletic activities. This program is coordinated by the athletic director who works with the coaches and student athletes to develop individual athletic abilities, team competitiveness, sportsmanship, and school spirit. The school relies on volunteer coaches who give of their time and talent.

St. Mary's is a member of the Peninsula Independent Athletic Association League (PIAL) which allows us to compete in coed soccer, cross-country, basketball, baseball, softball, and volleyball with other private schools throughout Hampton Roads.

Athletic Eligibility: Students in grades 5-8 are eligible to participate in the athletic program. Missing homework, poor grades, disciplinary problems, and excessive unexcused tardiness or absences will result in temporary suspension of eligibility. Students must be at school by 11:00 am on game day in order to play in a game that day. Exceptions may be made if a doctor's note is provided upon arrival to school. Any student obtaining a grade of 76% or lower on a Progress Report or Report Card will be ineligible to participate until the grade has improved to a passing level.

Student Code of Conduct: In order to achieve an atmosphere conducive to learning and growth, all student athletes must adhere to the *Student Code of Conduct*. In addition to the *Student Code of Conduct*, students representing the school through the athletic programs are asked to comply with the following standards:

- Express sportsmanlike conduct to other teammates, opponents, and observers at all practices and events.
- Follow all procedures and directions set forth by the coaching staff.
- Immediately inform coaches in the event they are ill or injured.
- Respect the abilities of other athletes and uphold the spirit of the school.

Athletic Fees: Due to the cost of uniforms, equipment, and officials, an athletic fee will be collected. Each student shall pay \$50 per sport. Forms and fee should be turned in to the office. Checks should be made payable to St. Mary Star of the Sea School and should be included with the registration form.
